### Parental and Family Engagement Plan 2022-2023

#### Jointly Developed

Baldwyn Elementary School solicits input into the parent and family engagement plan. #### Annual Title I Meeting

#### **Communications**

Baldwyn Elementary School shall:

- 1. - 2. Offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, child care, or home visits, as such services relate to parental involvement.
- 3. Involves parents/guardians in an organized, ongoing, and timely way, in the planning, review, and improvement of its parent involvement programs, the school's parental involvement policy, and the integration of these programs into the Schoolwide Plan.
- 4. Develops and maintains consistent and effective communication between the home and school.
- 5. Provides a description and explanation of the school's curriculum, forms of academic assessments used to measure student progress, and the proficiency levels students are expected to meet.
