Important Information for Schools



Spectator Information:

- No outside food allowed. Concessions will be available on site.
- Quarterfinal game admission will be \$10.00 each day.
- Tickets will be available at GoFan.co
- Clear bag policy for spectators.

Team Information:

- The team on the TOP of the bracket is the designated home team and must wear WHITE jerseys.
- The team on the BOTTOM of the bracket is the visiting team and must wear DARK jerseys.
- No outside food is allowed. Concessions will be available on site.
- Only the starting lineups will be announced (not entire roster).
- There will be 25 chairs on the sidelines (maximum number of 20 players in uniform).
- Warmups allowed only in the time immediately following the previous game (no warmup at halftime of previous game and no shootarounds at host facility in advance).
- If teams have warmup tops with hoods attached, the hoods may NOT be worn at any time inside the facility (pregame or warmup).
- The pregame conference will include head coaches, game administrators, and officials.
- There are no hospitality rooms available.
- Teams need to bring their own towels, bottled water, and ice if needed.

Broadcast Information:

Schools will have the option to broadcast games via live stream or radio unless the NFHS Network opts to be on site and provide exclusive live stream coverage at that site.

- **Live Television** – Contact MHSAA for permission and rights fee details.
- **Live Video Streaming** – \$200.00 (all classifications) | Must notify MHSAA at least 24 hours in advance by emailing marketing@misshsaa.com. *NOTE: No fee for NFHS Network member schools broadcasting exclusively on the NFHS Network.*
- **Delayed Video Streaming** – \$125.00 (all classifications) | Must be delayed at least 12 hours after start of event. Must notify MHSAA at least 24 hours in advance by emailing marketing@misshsaa.com.
- **Live Audio on Radio or Internet** – \$100 (all classifications) | Must contact MHSAA for permission at least 24 hours in advance by emailing marketing@misshsaa.com.
- **Delayed Audio on Radio or Internet** – \$50 (all classifications) | Must be delayed at least 12 hours after start of event. Must contact MHSAA for permission at least 48 hours in advance by emailing marketing@misshsaa.com
